MediPurpose values the trust its customers place in our company. This Privacy Policy is intended to explain what MediPurpose does with your information, and what you can expect from MediPurpose. What type of information does MediPurpose collect and how is it used?

MediPurpose gathers only the customer information that we need to administer our business, our security, the security of our customers and members to provide superior products and service.

There are two categories of information we collect about you when you visit our site. The first type of information we may collect about you is personally identifiable information, such as, your name, address, telephone number and e-mail address. This type of information may be provided as part of a purchase process and allows us to process and fulfill your requests for product information or product samples. Other examples of when we collect personally identifiable information are if you subscribe to our newsletter.

The second category is non-personally identifiable information. Data such as your IP address, browser type, domain name, specific web pages through which you click, and files you download are gathered in order to gain a better understanding of product, service and site development needs and provide an effective means of security for our website, our customers and members. This data is collected automatically and utilized in aggregate to help us look for trends so that we can improve our Website and your user experience.

What information do we share and with whom?

MediPurpose does not rent, lease, redistribute or sell customer information to any marketer. In certain circumstances, it may be necessary for MediPurpose customer information be accessed by third party services to provide operational or other support services for our website. To ensure the confidentiality and security of your information, service providers must agree to safeguard your information in compliance with our policy. In cases of fraud or other types of abuse, we also may provide information to regulatory authorities and law enforcement officials in accordance with applicable law or when we otherwise believe in good faith that the law requires it.

How does MediPurpose ensure that your information is secure?

MediPurpose will maintain practices and procedures designed to ensure the security, integrity and confidentiality of customer's credit card numbers. We restrict and limit access to customer information only to those employees who need it to carry out their business functions.

Does MediPurpose use cookies?

No, the MediPurpose web site does not utilize the data markers referred to as cookies.

Can I "opt out" of receiving promotional e-mails from MediPurpose?

MediPurpose may send you e-mails with news, promotional offers and announcements only if you opt-in to any of our newsletters which requires the verification of your email address to receiving such e-mails. If you would no longer wish to receive e-mailed special events information, sales notifications or other messages from MediPurpose, you may "unsubscribe" at any time.
